The Government of Montenegro has received a loan in the amount of EUR 6 million from the International Bank for Reconstruction Development (IBRD) toward the cost of the Second Energy Efficiency Project-MEEP 2, and intends to apply part of the proceeds to payments for the Construction Works on ***General Hospital Nikšić, Health Center Mojkovac and Health Center Danilovgrad.***

The Ministry of Economy and Ministry of Health through the Technical Service Unit invites sealed bids for the civil construction works for **Implementation of measures to improve the ENERGY EFFICIENCY** on existing health facilities situated in: **Nikšić, Mojkovac and Danilovgrad.** Works will include construction-craft works, electrical installation works, partial replacement of old luminaries, thermal insulation of façade walls, flat roof with all the layers of thermal and multi-layered waterproofing membrane, partial replacement of joinery, painting works, sheet metal works, works in boiler room, testing of installations etc.

Qualifications requirements, among others, includes:

- a) Minimum average annual construction turnover of 2,5 million EUR, calculated as total certified payments received for contracts in progress and/or completed within the last three years (2017, 2018, 2019), divided by three years.
- b) A minimum number of similar contracts specified below that have been satisfactorily and substantially completed as a prime contractor, joint venture member, management contractor or sub-contractor between 1st January 2017 and application submission deadline: (i) two (2) contracts, each of minimum value 700,000.00EUR, or minimum one (1) Contract, minimum value of 1,4million EUR;
- c) The minimum amount of liquid assets and/or credit facilities net of other contractual commitments of the successful Bidder shall be 330,000.00EUR;
- d) Prior to contract signing successful Bidder is obliged to provide necessary licenses for works performing, firm and staff (as defined in the bidding document) and in accordance with the Law on Spatial Planning and Construction of Structures (*Official Gazette of Montenegro 64/17, 44/18, 63/18 from 28.09.2018*).

Bidding will be conducted through the Request for Bids-National market approach, procedures as specified in the World Bank's ***Procurement Regulations for Investment Project Financing (IPF) Borrowers'***, issued in July 2016 revised November 2017, and is open to all eligible bidders

as defined in the Procurement Regulations. In addition, please refer to paragraphs 3.14 setting forth the World Bank's policy on conflict of interest.

Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below ***October 01, 2020, 12:05h***.

All bids must be accompanied by a *Bid Security declaration*.
