The Government of Montenegro has received a loan in the amount of EUR 6 million from the International Bank for Reconstruction Development (IBRD) toward the cost of the Second Energy Efficiency Project-MEEP 2, and intends to apply part of the proceeds to payments for the **Construction Craft Works on 5 (five) Public Health facilities: *General Hospital NIKŠIĆ, Health Center MOJKOVAC, Health center DANILOVGRAD, Health Station ŽABLJAK and Health Center PODGORICA – “Block V”.***

The Ministry of Capital Investments and Ministry of Health through the Technical Service Unit, invites sealed bids for the construction craft works for **Implementation of measures which have an effect to improve and increase the “ENERGY EFFICIENCY”** on existing five health facilities situated in: **Nikšić, Mojkovac, Danilovgrad, Žabljak and Podgorica.** The projected term for realization is **210 days** in total.

Bidding process will be conducted through the **Request for Bids-National market approach**, procedures as specified in the World Bank’s ***Procurement Regulations for Investment Project Financing (IPF) Borrowers’, issued in July 2016 revised November 2017 and August 2018,*** and it is open to all eligible bidders as defined in the Procurement Regulations. In addition, please refer to paragraphs 3.14 setting forth the World Bank’s policy on conflict of interest.

A complete set of bidding documents in English may be purchased by interested eligible bidders, and will be sent by email to interested bidders, upon the submission of a written application and proof of payment of a non-refundable fee of 100,00EUR on the account **832-1191-19**, to the email address below. Interested bidders may obtain further information at the same e-mail address.

Considering that this is repeated process, Bidders - Companies which (last year), already have purchased documentation for mostly similar SPN, are not obliged to pay again. Submission of request with information about interested bidder (company) for receiving of SBD (set of Standard Bidding document) will be sufficient for registration and participation in this new bidding process.

Prior to contract signing successful Bidder is obliged to provide necessary licenses for works performing, (as defined in the bidding document) and in accordance with the Law on Spatial

Planning and Construction of Structures (Official Gazette of Montenegro 64/17, 44/18, 63/18 from 28.09.2018). All bids must be accompanied by a **Bid Security declaration**.

Pre Bid conference for all interested and eligible bidders, will be held on **June 28, 2023 at 10:00h** in TSU office. One person from each company is allowed to participate to this event.
