- 1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in *Development Business*, issue online on February 17, 2014
- 2. The Government of Montenegro has applied for financing in the amount of EURO 5,000,000.00 (US\$ 6,800,000 equivalent) from the World Bank toward the costs of the **Additional Financing for the Montenegro Energy Efficiency Project Additional Financing (MEEP AF)** and it intends to apply part of the proceeds to payments for Thermotechnical Installations with electrical installations at the Clinic Centre Montenegro.
- 3. Technical Services Unit TSU (under Ministry of Finance), in the name of Ministry of Economy and Ministry of Health invite sealed bids for electro works:

Works include as follows: Thermotechnical Installations with electrical installations at the Clinic Centre Montenegro.

The contracts will be awarded to the lowest evaluated qualified bidder. The bidder has to meet the qualification requirements stated in the bidding document.

- 4. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the World Bank's <u>Guidelines: Procurement under IBRD Loans and IDA Credits</u> January 2011 and it is opened to all bidders from Eligible Source Countries as defined in the Bidding Documents.
- 5. Interested eligible bidders may obtain further information from 10:00 to 17:00 local time and inspect the Bidding Documents at the address given below.

- 6. Qualifications requirements include:
 - a) Proof of legal status and place of registration;
 - b) The average annual financial amount of construction works over the period of last three years (2013, 2012, 2011) should be not less than: **2,900,000.00EUR**
 - c) Experience under contracts in the role of contractor, subcontractor, or management contractor for at least the last **three** [3] **years** (**starting 1st January 2011**) prior to the applications submission deadline, and with activity in at least **nine** (9) **months** in each year.
 - d) Participation as contractor, management contractor, or subcontractor, in at least **two** [2] contracts within the last **three** (3) **years** (**starting** 1st **January** 2011), and application submission deadline, each with a value of at least: 600,000.00EUR, or minimum one contract, with total value equal or more than 1,200,000.00EUR that have been successfully and substantially completed and that are similar to the proposed Works. The similarity shall be based on the physical size, complexity, methods/technology.
 - e) Construction equipment requested to carry out the Contract;
 - f) Qualifications and experience of key personnel proposed for the Contract;
 - g) The minimum amount of liquid assets: (a statement issued by a Bank): 350,000.00EUR
 - h) Proofs of financial standing of the Bidder for the past 3 years;
 - i) Information regarding any litigation since 1st January 2009, in which the Bidder was/is involved, the parties concerned, and the disputed amounts; and awards;
 - j) Awarded bidder will provide prior the Contract signature the following licences:
 - -License for thermo-technical works;
 - -License for electrical works (High power and Low power);
 - -License for civil-construction works;
