## **Invitation for Bids (IFB)**

The Government of Montenegro has received a loan in the amount of EUR 6 million from the International Bank for Reconstruction Development (IBRD) toward the cost of the Second Energy Efficiency Project-MEEP 2, and intends to apply part of the proceeds to payments for the Works on Health center Berane, Health Center Plav and Health Center Rožaje.

The Ministry of Health through the Technical Service Unit invites sealed bids for the Works on Health center Berane, Health Center Plav and Health Center Rožaje. Works will include construction-craft works, electrical installation works, hydraulic balancing of heating installations and installations of radiator thermostatic valve, water supply and sewage installation works, boiler plant, testing of installation.

Qualifications requirements, among others, includes:

- a) Minimum average annual construction turnover of 3 million EUR, calculated as total certified payments received for contracts in progress and/or completed within the last three years (2015, 2016, 2017), divided by three years.
- b) A minimum number of similar contracts specified below that have been satisfactorily and substantially completed as a prime contractor, joint venture member, management contractor or sub-contractor between 1st January 2014 and application submission deadline: (i) two (2) contracts, each of minimum value 500,000.00EUR, or minimum one (1) Contract, minimum value of 1,000,000.00EUR;
- c) The minimum amount of liquid assets and/or credit facilities net of other contractual commitments of the successful Bidder shall be 200,000.00EUR;
- d) Prior to contract signing successful Bidder is obliged to provide necessary licenses, equipment and staff (as defined in the bidding document).

Bidding will be conducted through the Request for Bids-National market approach, procedures as specified in the World Bank's *Procurement Regulations for Investment Project Financing (IPF) Borrowers'*, *issued in July 2016*, and is open to all eligible bidders as defined in the Procurement Regulations. In addition, please refer to paragraphs 3.14 setting forth the World

Bank's policy on conflict of interest.
