- 1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in *Development Business*, issue online on 11 February 2009.
- 2. Montenegro has received a loan from the International Bank for Reconstruction and Development (IBRD) in the amount of € 6.5 million equivalent toward the cost of the Montenegro Energy Efficiency Project (MEEP), and intends to apply part of this loan to payments under the contract for "Reconstruction of General Hospital Bijelo Polje", MNE-EE-7637-NCB-W-09-B1.
- 3. Technical Services Unit TSU for World Bank Project (established under Ministry of Finance), in the name of Ministry of Economy and Ministry of Health invite sealed bids for:

"Reconstruction of General Hospital Bijelo Polje" MNE-EE-7637- NCB-W-09-B1

Works include as follows: **LOT 2: Thermo-technical installation with associated electro works** A. Works on thermo-technical installations B. Electro works

The Intended Completion Date is 45 days after signing the Contract.

- 4. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the World Bank's *Guidelines: Procurement under IBRD Loans and IDA Credits- (edition May 2004, revised October 2006 and May 2011)* and are open to all bidders from Eligible Source Countries as defined in the Bidding Documents.
- 5. Interested eligible bidders may obtain further information from 10:00 to 17:00 local time and inspect the Bidding Documents at the address given below.
- 6. Qualifications requirements include:

- a) Proof of legal status and place of registration;
- b) The average annual financial amount of construction works over the period of last three years (2010, 2009, 2008) should be not less than **EUR 435,000.00.**
- c) The experience as main contractor in implementation of at least 2 similar contracts of construction works of a nature and complexity similar to the works over the period of last three years (2010, 2009, 2008) (to comply with this requirement, works cited should be at least 70 percent complete, bidders should submit the confirmation from investor regarding the level and quality of completed works):
 - (i) Not less than two similar contracts in last three years for construction/reconstruction/modernization of boiler rooms fired by fuel oils (LFO, HFO) with total capacity 700 kWth or more, including boiler(s) with associated systems, equipment, fittings, piping, flue gas ducts with stack, C & I system, and necessary equipment for safe (fire protection systems, explosion protection, safety at work, etc.)
 - (ii) Not less than two contracts in last three years for reconstruction or new works on lighting and electrical installation each contract of at least 12.000 EUR.
- d) Construction equipment requested to carry out the Contract;
- e) Qualifications and experience of key personnel proposed for the Contract;
- f) The minimum amount of liquid assets: (a statement issued by a Bank). LOT 2: **80.000.00 EUR**
- g) Proofs of financial standing of the Bidder for the past 3 years;
- h) Information regarding any litigation during the last five years, in which the Bidder was/is involved, the parties concerned, and the disputed amounts; and awards;
- i) Selected Contractor will provide prior the Contract signature the License for performing thermo-technical installations and License for performing electro installation works in accordance with bylaw regulations.
- 7. A complete set of Bidding Documents in Montenegrian may be purchased by interested bidders on the submission of a written Application to the address below and upon payment of a non refundable fee of 50 EUR.
