- 1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in *Development Business*, issue online on 11 February 2009.
- 2. Montenegro has received a loan from the International Bank for Reconstruction and Development (IBRD) in the amount of € 6.5 million equivalent toward the cost of the Montenegro Energy Efficiency Project (MEEP), and intends to apply part of this loan to payments under the contract for Installation of energy efficient luminaries in Main Hospital Building in Clinic Centre Podgorica.
- 3. Technical Services Unit TSU (under Ministry of Finance), in the name of Ministry of Economy and Ministry of Health invite sealed bids for electro works:

Works include as follows:

• Installation of energy efficient luminaries in Main Hospital Building in Clinic Centre Podgorica

The contracts will be awarded to the lowest evaluated qualified bidder. The bidder has to meet the qualification requirements stated in the bidding document.

- 4. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in the World Bank's *Guidelines: Procurement under IBRD Loans and IDA Credits- version May 2004.revised October 2006 and May 2010* and it is opened to all bidders from Eligible Source Countries as defined in the Bidding Documents.
- 5. Interested eligible bidders may obtain further information from 10:00 to 17:00 local time

and inspect the Bidding Documents at the address given below.

- 6. Qualifications requirements include:
 - a) Proof of legal status and place of registration;
 - b) The average annual financial amount of construction works over the period of last three years (2012, 2011, 2010) should be not less than: **1,200,000.00EUR**
 - c) Experience under contracts in the role of contractor, subcontractor, or management contractor for at least the last three [3] years prior to the applications submission deadline, and with activity in at least nine (9) months in each year.
 - d) Participation as contractor, management contractor, or subcontractor, in at least two
 [2] contracts within the last three (3) years, each with a value of at least: 350,000.00EUR that have been successfully and substantially completed and that are similar to the proposed Works. The similarity shall be based on the physical size, complexity, methods/technology.
 - e) Construction equipment requested to carry out the Contract;
 - f) Qualifications and experience of key personnel proposed for the Contract;
 - g) The minimum amount of liquid assets: (a statement issued by a Bank): **90,000.00EUR**
 - h) Proofs of financial standing of the Bidder for the past 3 years;
 - i) Information regarding any litigation during the last five years, in which the Bidder was/is involved, the parties concerned, and the disputed amounts; and awards;
 - j) Selected Contractor will provide prior the Contract signature the License for performing electro installation works in accordance with laws of Montenegro.
