





INVITATION FOR BIDS

INSTALLATION OF SOLAR SYSTEMS ON HOUSEHOLDS UNDER PROJECT MONTESOL

- Ministry of Economy of Montenegro, in cooperation with United Nations Environmental Programme (UNEP) and Italian Ministry for Environment, Land and Sea (IMELS), implements the project MONTESOL, aimed at offering an attractive and sustainable financial mechanism for obtaining a retail loan to install Solar Water Heating (SWH) systems. For the MONTESOL project, funds in the amount of 1 million USD were envisaged for project implementation and management and specifically to subsidize the interest rate of commercial banks.
- 2. In order to successfully implement the program MONTESOL, the selection procedure of dealers/installers of solar water heating systems will be undertaken. This procedure shall include the suitable solar water heating system equipment that will be built into the customers' facilities.
- 3. ME/SEE, which is hereby representing the Ordering Party, hereby invites all dealers and/or installers of solar-water heating equipment to apply to this Invitation for Bids (IFB) and prepare offers to be evaluated, assessed and included as partners in the MONTESOL project.

The offer shall comply with eligibility and evaluation criteria, as well as all terms and conditions outlined in the tender documentation available by request on e-mail: <u>info@ee-me.org</u> until the deadline for submission of offers. The bidder is required to leave contact details for the future reference.
- 5. The Bidder shall bear all costs associated with the preparation and submission of his Bid, and the Employer shall in no case be responsible or liable for those costs.
